

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving for Reapplication of the Expansion of Substance Abuse
Treatment Capacity Proposal and Budget for Fiscal Year 2000)

RESOLUTION NO. 99-229

1 WHEREAS, the Tohono O'odham Legislative Council has approved a three year
2 proposal in the total amount of \$1,751,668.00 for the Department of Human
3 Services, Division of Alcohol/Substance Abuse Program to expand
4 substance abuse treatment in targeted areas of need; and

5 WHEREAS, the Department of Human Services through the Division of Alcohol and
6 Substance Abuse is submitting for the reapplication of the second year for
7 FY 2000.

8 NOW, THEREFORE, BE IT RESOLVED,

- 9 1. That the Tohono O'odham Legislative Council does hereby approve
10 for the reapplication of the second year proposal in the budgeted
11 amount of \$580,956.00, to establish expanded substance abuse
12 treatment and services, and authorizes expenditures in accordance to
13 the attached grant and the second year annual budget.
- 14 2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice
15 Chairman and any designated Official are hereby authorized to
16 negotiate and execute the grant and expend such funds when
17 received.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 06TH day
19 of MAY, 1999 at a meeting at which a quorum was present with a vote of 1,738.0 FOR; -0-
20 AGAINST; -0- NOT VOTING; and 189.0 [07] ABSENT, pursuant to the powers vested in
21 the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham
22 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
23 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
24 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


