

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 99-233, "Approving Mining Lease Addendum
No. 4 with Cyprus Tohono Corporation Deferring Payment of a Portion
of the Advance Minimum Royalty")**

RESOLUTION NO. 99-234

1 WHEREAS, the Legislative Council on May 07, 1999 did enact Resolution No. 99-233,
2 *Approving Mining Lease Addendum No. 4 with Cyprus Tohono Corporation*
3 *Deferring Payment of a Portion of the Advance Minimum Royalty"; and*

4 WHEREAS, a motion was made to amend the NOW, THEREFORE, BE IT RESOLVED
5 clause.

6 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
7 hereby amends Resolution No. 99-233 in its final resolving clause to read:

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
9 Legislative Council hereby approves the Mining Lease Addendum No. 4
10 with Cyprus Tohono Corporation and authorizes the Chairman of the
11 Nation to sign the Addendum in a form agreeable to the Bureau of Indian
12 Affairs, and to sign any other documentation needed to accomplish the
13 purposes of the agreement.

14 The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH day
15 of MAY, 1999 at a meeting at which a quorum was present with a vote of 1,312.5 FOR;
16 614.5 AGAINST; 0 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in
17 the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham
18 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
19 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
20 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


