

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointments of the O'odham Charitable Advisory Board
to the O'odham Charitable Office)**

RESOLUTION NO. 99-236

1 WHEREAS, a special election was held on June 28, 1997 known as the "O'odham
2 Voice" that provides a charitable organization within the Nation to "Create
3 an 11 member Board (1 member from each District) to establish an
4 O'odham Charitable Organization (OCO) on the reservation"; and

5 WHEREAS, Resolution No. 99-188 was passed on April 19, 1999 amending Resolution
6 No. 98-374, "Approving the Establishment of an O'odham Charitable
7 Office and an Operational Budget of \$220,138.75 and Confirming the
8 Appointment of an Interim Advisory Board" to reinstate the District
9 Chairpersons of the eleven Districts to continue to discharge the duties of
10 the office, until the May 1999 General Session of the Legislative Council;
11 and

12 WHEREAS, the following were identified by the Vice Chairman of the Nation together
13 with the Rules Committee as qualified candidates for appointments:
14 Pisinemo District, Mrs. Geraldine Mariano; Sif Oidak District, Mr. Gilbert
15 Thomas; Gu Achi District, Mrs. Rose Martin; Baboquivari District, Miss
16 Genevieve Porter; San Lucy District, Ms. Edith Ortiz; San Xavier District,
17 Mrs. Irene Alvarez-Begay; Schuk Toak District, Mrs. Teresa Donahue;
18 Hickiwan District, Miss Glenna Francisco; Gu Vo District, Mrs. Clara
19 Arviso; and two Districts have vacancies, Chukut Kuk District and Sells
