

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Certifying Tohono O'odham Nation's Commitment to Contribution
of Leverage for the 1999 ANA Land Use Planning Project)

RESOLUTION NO. 99-238

1 WHEREAS, the Nation's Districts and their members, through their participation in
2 and acceptance of the Chairman's Administrative Plan have requested land
3 use planning for the Nation to facilitate attracting economic development
4 opportunities, as well as to resolve land use issues for commercial and
5 residential development; and

6 WHEREAS, such land use planning is an eligible activity under the Administration for
7 Native Americans - SEDS grant; and

8 WHEREAS, the ANA grant criteria require leverage for maximum points and funding;
9 and

10 WHEREAS, the grant minimum for leveraged dollars is 20% of the total direct project
11 cost to ANA; and

12 WHEREAS, twenty per cent of the total project cost to ANA is \$105,119.00; and

13 WHEREAS, the cost of this leverage shall come from the Nation's General Fund.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation does certify
15 and commit \$105,119.00 to the cost of the Land Use Plan as proposed under
16 the ANA grant application.

17 The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH day
18 of MAY, 1999 at a meeting at which a quorum was present with a vote of 1,766.0 FOR; -0-
19 AGAINST; -0- NOT VOTING; and 161.0 [05] ABSENT, pursuant to the powers vested in
20 the Council by Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono
21 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
22 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
23 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
