RESOLUTION NO. 99-240

1 WHEREAS, the Tohono O'odham Legislative Council is charged with the
2 responsibility to maintain the general welfare of its members; and

3 WHEREAS, a proposal was submitted by the San Lucy District Elderly Program to the
4 District Council requesting use of P.L. 99-503 funds to Insulate 7 Elderly
5 Homes; and

6 WHEREAS, the San Lucy Council in session did review the proposal submitted by the
7 Elderly Program and recognize the need to insulate these homes to be
8 energy efficient and further approved that P.L. 99-503 funds be used for
9 this purpose; and recommend that the Tohono O'odham Legislative
10 Council approve the request; and

11 WHEREAS, the Budget and Finance Committee reviewed the proposal on Wednesday,
12 May 05, 1999, and determined that it would be in the better interest of the
13 San Lucy District to use P.L. 99-503 funds.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that
15 it hereby approves the San Lucy District Elderly Program, Insulation
16 Project.

17 BE IT FURTHER RESOLVED that \$42,476.00 be appropriated from P.L. 99-503 funds.

18 BE IT FINALLY RESOLVED that the funds be wire transferred to the San Lucy District
19 General Account, Account No. 8221861432 Community First Bank - Gila
20 Bend, Arizona.
