**RESOLUTION NO. 99-241**

1 WHEREAS, the American Indian Social Work Student Association of the Arizona State  
2 University hosts an annual banquet to recognize and enhance the academic  
3 and social and cultural growth of American Indian students and members  
4 of the surrounding tribal communities; and

5 WHEREAS, the Convocation Banquet will be held on Saturday, May 15, 1999 at Fort  
6 McDowell to honor all graduating students in the field of social work,  
7 including five (5) from the Tohono O'odham Nation; and

8 WHEREAS, the organization is requesting a monetary donation from the Tohono  
9 O'odham Nation in the amount of \$1,000.00 to meet the needs of the  
10 ceremony; and

11 WHEREAS, the Budget & Finance Committee supports the request of AISWSA.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council  
13 approves the monetary donation in the amount of \$1,000.00 to the  
14 American Indian Social Work Student Association.

15 BE IT FURTHER RESOLVED that the monetary donation be appropriated from the  
16 general revenue account.

17 The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH day  
18 of MAY, 1999 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0-  
19 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the  
20 Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham  
21 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by  
22 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
23 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
