Day of MAY, 1999 at a meeting at which a quorum was present, and by a vote of 578.5 FOR; 1,348.5 AGAINST; -0- NOT VOTING; and [05] ABSENT, failed to pass because it did not receive a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono O'Odham Nation.
