10	of <u>578.5</u> FOR; <u>1,348.5</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[05]</u> ABSENT, failed to pass
11	because it did not receive a majority of the votes cast as required by Section 2 of Article
12	V of the Constitution of the Tohono O'odham Nation.
