5	Enrollment Committee serve notice of Rejection of the application in							
6	accordance with the provisions of Sections 1 and 2, Article VIII of the							
7	Enrollment Ordinance.							
8	The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on							
9	the <u>18<sup>TH</sup></u> . Day of <u>MAY</u> , 1999 at a meeting at which a quorum was present, and by a vote							
10	of <u>578.5</u> FOR; <u>1,348.5</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[04]</u> ABSENT, failed to pass							
11	because it did not receive a majority of the votes cast as required by Section 2 of Article							
12	V of the Constitution of the Tohono O'odham Nation.
