7 WHEREAS, the Enrollment Committee has reviewed the application and has
8 recommended that the application be denied because the applicant failed
9 to establish the following membership requirement(s): TOHONO
10 O'ODHAM CONSTITUTION, ARTICLE II, MEMBERSHIP - SECTIONS
11 (1) (a) & (b); and

12 WHEREAS, the application has come on for hearing before this Council; and

13 WHEREAS, the Enrollment Committee did serve written notice of its recommendation
14 to reject the application and of this hearing, as required by Section 2,
15 Article VI of the Enrollment Ordinance, upon the person who filed the
16 application and such person was not present at this hearing; and

17 WHEREAS, the Tohono O'odham Council has reviewed all of the evidence presented
18 and from such evidence finds that the applicant has failed to establish the
19 foregoing membership requirement(s).

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that
21 it does hereby determine that the application of:

for enrollment as a member of the Tohono O'odham Nation is hereby rejected.


BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve notice of Rejection of the application in accordance with the provisions of Sections 1 and 2, Article VIII of the Enrollment Ordinance.

The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 18TH. Day of MAY, 1999 at a meeting at which a quorum was present, and by a vote of 828.5 FOR; 1,098.5 AGAINST; -0- NOT VOTING; and [04] ABSENT, failed to pass because it did not receive a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono O'odham Nation.
