9	the 18^{TH} . Day of MAY, 1999 at a meeting at which a quorum was present, and by a vote
10	of 828.5 FOR; 1,098.5 AGAINST; -0- NOT VOTING; and [04] ABSENT, failed to pass
11	because it did not receive a majority of the votes cast as required by Section 2 of Article
12	V of the Constitution of the Tohono O'odham Nation.
