7 WHEREAS, the Enrollment Committee has reviewed the application and has
8 recommended that the application be denied because the applicant failed
9 to establish the following membership requirement(s): TOHONO
10 O'ODHAM CONSTITUTION, ARTICLE II, MEMBERSHIP - SECTIONS
11 (1) (a) & (b); and

12 WHEREAS, the application has come on for hearing before this Council; and

13 WHEREAS, the Enrollment Committee did serve written notice of its recommendation
14 to reject the application and of this hearing, as required by Section 2,
15 Article VI of the Enrollment Ordinance, upon the person who filed the
16 application and such person was not present at this hearing; and

17 WHEREAS, the Tohono O'odham Council has reviewed all of the evidence presented
18 and from such evidence finds that the applicant has failed to establish the
19 foregoing membership requirement(s).

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that
21 it does hereby determine that the application of:

2 BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation shall
3 issue a certificate of Final Determination of Rejection and that the
4 Enrollment Committee serve notice of Rejection of the application in
5 accordance with the provisions of Sections 1 and 2, Article VIII of the
6 Enrollment Ordinance.

8 The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day
9 of MAY, 1999 at a meeting at which a quorum was present with a vote of 1,292.5 FOR;
10 492.5 AGAINST; 142.0 NOT VOTING; and [05] ABSENT, pursuant to the powers vested
11 in the Council by Section 1 (h) of Article VI of the Constitution of the Tohono O'Odham
12 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
13 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
14 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
