RESOLUTION NO. 99-267

1 **WHEREAS, the Tohono O'odham Nation did on Saturday, May 22, 1999 conduct a**
2 **general election for the offices of Chairman and Vice Chairman of the**
3 **Tohono O'odham Nation, as well as Representatives and Alternates to the**
4 **Tohono O'odham Legislative Council; and**

5 **WHEREAS, on May 23, 1999 the Election Board did issue and post its attached**
6 **Certificates of Election Results for the offices of Chairman and Vice**
7 **Chairman of the Tohono O'odham Nation, as well as Representatives and**
8 **Alternates to the Tohono O'odham Legislative Council which are referred**
9 **to as exhibits "1" to "12" and incorporated herein by this reference in**
10 **accordance with Section 6(K) of Article VII of the Uniform Election**
11 **Ordinance; and**

12 **WHEREAS, pursuant to Section 1(B) of Article VII of the Uniform Election Ordinance,**
13 **on May 23, 1999 the Election Board did post the attached Certificate of**
14 **District Residents which is referred to as exhibit "13" and incorporated**
15 **herein by this reference which establishes the number of votes each**
16 **District is entitled to cast at the Tohono O'odham Legislative Council in**
17 **accordance with Section 2 of Article V of the Constitution of the Tohono**
18 **O'odham Nation.**

19 **WHEREAS, Section 6(N) of Article VII of the Uniform Election Ordinance requires that**
20 **the Legislative Council seat and for Chairman and Vice Chairman of the**
21 **Nation within twenty days after the Election Board has posted its**

1 Certificate of Election results; provided however, that no election contest
2 statement has been filed against the candidates within the time allowed
3 and provided for; and provided further that they hold no other elective
4 office of the Nation and in the case of Chairman and Vice Chairman of the
5 Nation such persons hold no other elective offices in the Nation and are
6 not employees of the Nation.

7 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 8 1. The Chairman and Secretary of the Tohono O'odham Legislative
9 Council are hereby authorized and directed on behalf of the Council
10 to execute and deliver a Certificate of Election seating the following
11 persons elected either at large as Chairman and Vice Chairman of the
12 Tohono O'odham Nation, or from their respective Districts as
13 Representatives and Alternates to the Tohono O'odham Legislative
14 Council, who shall hold their offices for a term of four (4) years and
15 until their successors are certified and seated, namely:




