9		to as exhibits "1" to "12" and incorporated herein by this reference in
10		accordance with Section 6(K) of Article VII of the Uniform Election
11		Ordinance; and
12	WHEREAS,	pursuant to Section 1(B) of Article VII of the Uniform Election Ordinance,
13		on May 23, 1999 the Election Board did post the attached Certificate of
14		District Residents which is referred to as exhibit "13" and incorporated
15		herein by this reference which establishes the number of votes each
16		District is entitled to cast at the Tohono O'odham Legislative Council in
17		accordance with Section 2 of Article V of the Constitution of the Tohono

19	WHEREAS,	Section 6(N) of Article VII of the Uniform Election Ordinance requires that
