**(Adoption into the Tohono O'odham Nation)**

**RESOLUTION NO. 99-310**

1 **WHEREAS, JOSE LUIS GARCIA-VALENCIA, NAZARIO LIZARRAGA-GARCIA and**  
2 **EDUARDO RUIZ-GARCIA have made application for adoption in the**  
3 **Tohono O'odham Nation pursuant to Section 2 of Article II of the**  
4 **Constitution of the Tohono O'odham Nation; and**

5 **WHEREAS, the Enrollment Committee has reviewed the respective application, and**  
6 **has made a final determination that JOSE LUIS GARCIA-VALENCIA,**  
7 **NAZARIO LIZARRAGA-GARCIA and EDUARDO RUIZ-GARCIA are ½**  
8 **degree or more of Papago-Tohono O'odham Indian blood, and has made**  
9 **a recommendation to the Tohono O'odham Council that the applications**  
10 **be approved, all in accordance with the provisions of the Enrollment**  
11 **Ordinance; and**

12 **WHEREAS, the Tohono O'odham Legislative Council has reviewed the**  
13 **recommendations of the Enrollment Committee and the evidence**  
14 **submitted in support of the individual applications.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**  
16 **that the application for adoption filed by:**

18 **NAZARIO LIZARRAGA-GARCIA   3893-ND-99**


19 **EDUARDO RUIZ-GARCIA         4010-ND-99**

2 of JUNE, 1999 at a meeting at which a quorum was present with a vote of 2,086.45 FOR;  
3 79.05 AGAINST; -0 NOT VOTING; and [01] ABSENT, pursuant to the powers vested  
4 in the Council by Section 2 of Article II and Section 1(h) of Article VI of the Constitution  
5 of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January  
6 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
7 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
8 984).
