**NOW, THEREFORE, BE IT RESOLVED** that it is hereby determined that the above named applicant is eligible for enrollment as a member of the Tohono O'odham Nation under Section 1(a) or (b) of Article II of the Constitution of the Tohono O'odham Nation, and that their application is approved, as herein above indicated.

**BE IT FURTHER RESOLVED** that the Chairman and other appropriate officers of the Tohono O'odham Nation reduce this final determination in writing regarding each of the foregoing applications for enrollment in accordance with Section 1(a) of Article XIII of the Enrollment Ordinance; give notice of this Council's determination in accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place the names of each applicant upon the membership roll of the Tohono O'odham Nation in accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.

1 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on  
2 the 08TH day of JUNE, 1999 at a meeting at which a quorum was present with a vote  
3 of 2165.5 FOR; -0 AGAINST; -0 NOT VOTING; and [01] ABSENT, pursuant to the  
4 powers vested in the Council by Section 1 of Article II and Section 1(h) of Article VI of  
5 the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
6 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
7 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
8 18, 1934 (48 Stat. 984).
