1	WHEREAS,	on June 28, 1997 the voters of the Tohono O'odham Nation (the "Nation")
2		approved Initiative No. IN-01-97 (the "Initiative"); and
3	WHEREAS,	the Initiative authorized funding from Gaming Revenues for several
4		measures, including a one-time per capita distribution of \$2,000 to each
5		member of the Nation enrolled on June 28, 1997 (the "Initial Per Capita
6		Distribution"); and
7	WHEREAS,	pursuant to Resolution 97-451, the Legislative Council adopted an
8		Initiative Funding and Implementation Plan (the "FIP") which authorized
9		the establishment of set-aside accounts for the Initial Per Capita
10		Distribution and other Initiative measures, and set certain conditions on
11		the expenditure of funds from such accounts; and
12	WHEREAS,	by Resolution 97-478, the Legislative Council approved the transfer of
13		funds from the Desert Diamond Savings Account to certain designated
14		set-aside accounts established at Bank of America Arizona, including the
15		sum of \$41.5 million to set-aside account no. 3030425-1067524 for the
16		Initial Per Capita Distribution (the "Per Capita Account"); and
17	WHEREAS,	three of the conditions to expenditure of the Per Capita Account specified
18		in the FIP are (1) approval by the Secretary of the Interior of a per capita
19		distribution plan (the "Revenue Allocation Plan") pursuant to the
20		requirements of the Indian Gaming Regulatory Act, 25 U.S.C. § 2710 (b)
21		(3); (2) acceptance by the Legislative Council of a Certification of Eligible

1		Members submitted by the Enrollment Office and based upon receipt of

4		Member, establishment of a restricted account at Bank of America for
5		deposit of such member's per capita payment; and
6	WHEREAS,	pursuant to Resolution 97-452, the Legislative Council adopted a Revenue
7		Allocation Plan and caused the Plan to be submitted for approval by the
8		Phoenix Area Office of the Bureau of Indian Affairs in accordance with
9		authority delegated to the Area Office by the Secretary of the Interior; and
10	WHEREAS,	by letter dated December 18, 1997, the Area Office approved the Revenue
11		Allocation Plan with respect to the Initial Per Capita Distribution and
12		disapproved the Plan with respect to the Biennial Per Capita Payments;
13		and
14	WHEREAS,	an agreement with Bank of America has not yet been finalized for the
15		establishment of the restricted accounts which is required as a condition
16		to disbursement of the Initial Per Capita Distribution to such accounts for
17		Minor Eligible Members; and
18	WHEREAS,	pursuant to Resolution Nos. 97-525, 98-010, 98-037, 98-084, 98-128, 98-192,
19		98-207, 98-278, 98-316, 98-360, 98-431, 98-478, 98-505, 99-006, 99-041, 99-
20		081, 99-142 and 99-201 the Legislative Council accepted and approved
21		Certifications of Eligible Members for the Initial Per Capita Distribution,

4	WHEREAS, all conditions under the laws of the United States and the Nation have
5	been satisfied to permit the disbursement of the Initial Per Capita
6	Distribution to the members listed in the Certification of Eligible
7	members.
8	NOW, THEREFORE, BE IT RESOLVED THAT:
9	1. The Tohono O'odham Legislative Council hereby accepts and
10	approves the Certification of Eligible Members, in the form attached
11	hereto.
12	2. The Legislative Council authorizes (a) the transfer of the sum of
13	\$86,000.00 from the Per Capita Account to the special checking
14	account no. 252-350-324 established at Bank of America Arizona (the
15	"Per Capita Checking Account"); and (b) upon the joint signature of
16	the Chairman and Vice Chairman of the Nation, issuance of a check
17	on the Per Capita Checking Account in the amount of (i) \$2,000 to
18	each Eligible Member residing in the United States and listed in the
19	attached Certification of Eligible Members and (ii) \$1,400 to each
20	Eligible Member residing outside the United States and listed in the
21	attached Certification, with the balance of \$600 withheld and remitted
22	to the Internal Revenue Service pursuant to the requirements of
