

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointment of Willard Anita as TERO Commissioner)

DEFEATED
RESOLUTION NO. 99-313

1 **WHEREAS, the Tohono O'odham Legislative Council pursuant to Section 6(B)(1) of**
2 **the TERO Ordinance No. 01-85 appoint Commissioners for a three year**
3 **term or until their successors are appointed and qualified; and**

4 **WHEREAS, the Domestic Affairs Committee is the oversight committee for "all**
5 **TERO matters" pursuant to Resolution No. 98-448 authorized by this**
6 **Council; and**

7 **WHEREAS, the Tohono O'odham Legislative Council by Res. No. 97-134 appointed**
8 **Phillip Antone to a term commencing April 1997 to April 1999; and**

9 **WHEREAS, Mr. Antone has resigned as a TERO Commissioner and the**
10 **commissionership is currently vacant; and**

11 **WHEREAS, the Domestic Affairs Committee conducted a Commissionership search**
12 **to address the expired term by publicly announcing the vacancy to all**
13 **Districts and requested that nominations be submitted for their**
14 **consideration; and**

15 **WHEREAS, the Domestic Affairs Committee did receive five (5) nominations to fill**
16 **the vacancy; and**

17 **WHEREAS, the Domestic Affairs Committee recommends to the Tohono O'odham**
18 **Legislative Council that Willard Anita be appointed as a member to the**
19 **TERO Commission.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
21 **hereby appoints Willard Anita as TERO Commissioner pursuant to**
22 **Section 6(B)(1) & (C) of TERO Ordinance No. 01-85, commencing upon**
23 **the effective date of this resolution and ending June 2002.**

1 The foregoing Resolution was presented to the Tohono O'odham Legislative Council on
2 the 08TH day of JUNE, 1999 at a meeting at which a quorum was present, and by a vote
3 of 812.95 FOR; 979.85 AGAINST; -0- NOT VOTING; and 372.7 [04] ABSENT, failed to
4 pass because it did not receive a majority of the votes cast as required by Section 2 of
5 Article V of the Constitution of the Tohono O'Odham Nation.
