3 WHEREAS, the Legislative Branch is requesting a salary adjustment to the attorney
4 position to reflect the actual increase in annual salary; and

5 WHEREAS, the Budget & Finance Committee on June 03, 1999 did review the FY 1999
6 Legislative Branch Budget Amendment No. 1 and recommends for
7 approval.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
9 hereby approves the FY 1999 Legislative Branch Budget Amendment
10 No. 1.

11 The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH day
12 of JUNE, 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR;
13 0 AGAINST; 0 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in
14 the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham
15 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
16 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
17 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
