**RESOLUTION NO. 99-319**

1   **WHEREAS, by Resolution 98-413, the Tohono O'odham Legislative Council approved**  
2                   **the Baboquivari District FY-99 budget; and**

3   **WHEREAS, any change in the justification or funding levels need Tohono O'odham**  
4                   **Legislative Council review and approval; and**

5   **WHEREAS, by Resolution 99-B-86, the Baboquivari District Council approved an**  
6                   **amendment and modification for Fresnal Canyon community; and**

7   **WHEREAS, the Tohono O'odham Legislative Council was presented with Fresnal**  
8                   **Canyon community's budget modification along with the creation of new**  
9                   **line item 850.32 Food in the amount of five hundred dollars and no cents**  
10                  **(\$500.00).**

11   **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**  
12                  **hereby approves the Fresnal Canyon/Baboquivari District community**  
13                  **budget amendment and modification in the amount of five hundred**  
14                  **dollars and no cents (\$500.00).**

15   **BE IT FURTHER RESOLVED that a new line item 850.32 Food be added to Fresnal**  
16                  **Canyon Community's/Baboquivari District FY-99 budget.**

17   **The foregoing Resolution was passed by the Tohono O'odham Council on the 09TH day**  
18   **of JUNE, 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR;**  
19   **-0- AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in**  
20   **the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham**  
21   **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by**  
22   **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
23   **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
