**RESOLUTION NO. 99-320**

1 WHEREAS, the Fire Department/Department of Public Safety has taken over  
2 operations of the Wildland Program from Bureau of Indian Affairs and  
3 will continue to operate the program indefinitely; and

4 WHEREAS, funding has been provided by BIA Wildland P.L. 93-638 cost Contract for  
5 the operation of the Wildland Program; and

6 WHEREAS, this funding is to be utilized to provide emergency services in the saving  
7 of lives, property, and protection of natural resources and wildlife to the  
8 members of the Tohono O'odham Nation; and

9 WHEREAS, the Fire Department/Department of Public Safety requests to transfer  
10 funding from Wildland Program P.L. 93-638 FY98 Budget; and

11 WHEREAS, the funding would be integrated into the Fire Department's FY99 Budget  
12 to be utilized to place the Wildland Program in operation and for the  
13 management of the daily operational expenses; and

14 WHEREAS, the Wildland budget funding would be incorporated into each individual  
15 line item for overall Wildland Program operations; and

16 WHEREAS, the request of funds transfer has been reviewed by the appropriate  
17 committees.

18 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council  
19 recommends the approval of establishing of the BIA Wildland P.L. 93-638  
20 funding from FY98 into a special revenue account for the Tohono  
21 O'odham Nation Fire Department Wildland P.L. 93-638 Program.

7 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


