

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the JTPA/NEW Program State of Arizona Welfare to Work
FY 1998 Plan and Budget)**

RESOLUTION NO. 99-323

1 WHEREAS, the Tohono O'odham Nation JTPA/NEW Program has been funded
2 through the State of Arizona Welfare to Work Grant in the amount of
3 \$82,949.00; and

4 WHEREAS, the Tohono O'odham Nation, in conjunction with our Department of
5 Labor Welfare to Work Grant will cost share any and all reasonable,
6 allowable and allocable charges; and

7 WHEREAS, the Welfare to Work program is designed to promote "work first" for long
8 termed subsidized income families; and

9 WHEREAS, the Job Training Plan works on and off the Tohono O'odham Nation with
10 referrals, case management, pre-employment training, Job Creation and
11 Support Services.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
13 does hereby approve the State of Arizona Welfare to Work FY 1998 Plan
14 and Budget.

15 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the
16 Tohono O'odham Nation's Officials, to wit: the Chairman and any
17 designated official are hereby authorized to negotiate and execute the
18 contract, provided however, that any amendments affecting the funding
19 or funding levels of this contract shall be submitted for further prior
20 approval by this Council.
