**RESOLUTION NO. 99-327**

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Community**  
2 **Health Services and Community Health Representatives for FY 1999**  
3 **under P.L. 93-638 Master Health Services Contract No. 249-96-0001 with**  
4 **the Indian Health Services; and**

5 **WHEREAS, the Tohono O'odham Nation's Grants and Contracts Office has notified**  
6 **the Community Health Services/Community Health Representative**  
7 **Divisions of \$874,802.84 of carry over funds available for obligation under**  
8 **the FY 98 Master Health Contract; and**

9 **WHEREAS, an amendment has been submitted for review and approval by the**  
10 **Department of Human Services, Divisions of Community Health Services**  
11 **and Community Health Representatives to utilize carry over funds to**  
12 **cover the salaries, fringe benefits for the remaining of the fiscal year; and**

13 **WHEREAS, the amendment requests and identifies expenditures in a new line item,**  
14 **"Office and Communication Equipment."**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**  
16 **that:**

- 17 **1. It hereby approves the amendment and authorizes expenditures in**  
18 **accordance with the attached budget modification #2 submitted by**  
19 **the Community Health Services/Community Health Representatives.**
- 20 **2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice**  
21 **Chairman and any designated official are hereby authorized to**  
22 **negotiate and execute contracts and expend funds when received.**
