LEGISLATIVE ORDER NO. 99-331

1	WHEREAS, the Tohono O'odham Legislative Council has scheduled seventeen (17) public
2	hearings to be held in the eleven districts and six (6) O'odham communities;

4	WHEREAS, the scheduled public hearings are in accordance with the adopted Legislative
5	Rules; and
6	WHEREAS, it is in the best interest of the Tohono O'odham Nation members that Tohono
7	O'odham Legislative Councilmembers not be compensated for attending
8	public hearings.
9	NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council does
10	hereby acknowledge the non-compensation for Legislative Councilmembers
11	while attending all scheduled public hearings.
12	The foregoing Order was passed by the Tohono O'odham Legislative Council on the <u>9TH.</u> day
13	of <u>IUNE. 1999</u> at a meeting at which a quorum was present with a vote of <u>1.879.0</u> FOR; <u>286.5</u>
14	AGAINST; <u>-0</u> -NOT VOTING; and <u>[0]</u> ABSENT, pursuant to the powers vested in the Council by
15	Section 1 (1) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
16	Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
18	of June 18, 1934 (48 Stat. 984).
