

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Completion of Tribal Responsibilities and Obligations related to Construction
of Facilities for Utilization of Central Arizona Project Water and Irrigation
Systems in the Eastern Schuk Toak District; Authorizing Expenditures from
SAWRSA Trust Fund)**

RESOLUTION NO. 99-334

1 **WHEREAS, the Southern Arizona Water Rights Settlement Act of 1982 (SAWRSA),**
2 **P.L. 97-293, directed the construction of facilities for the utilization of**
3 **Central Arizona Project water and irrigation systems in the eastern Schuk**
4 **Toak District; and**

5 **WHEREAS, construction activities set forth in P.L. 93-638 Grant Agreement 6-FG-32-**
6 **00100 have advanced to a point where activities beyond the scope of the**
7 **Agreement are feasible; and**

8 **WHEREAS, funds are available from interest earned on the SAWRSA Trust Fund and**
9 **from rental payments received for the use of the Schuk Toak Pipeline;**
10 **and**

11 **WHEREAS, the Tohono O'odham Nation must fulfill its responsibilities and**
12 **obligations as set forth in SAWRSA; and**

13 **WHEREAS, the Tohono O'odham Nation, through the Water Projects Office, has**
14 **developed a consistent and reliable construction process and has**
15 **successfully administered more than 35 construction contracts; and**

16 **WHEREAS, a consistent and timely process would promote cost controls in the**
17 **Nation's construction obligations.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**
19 **that, in order to remain consistent with the contracting processes**
20 **established in the P.L. 93-638 Grant Agreement, hereby directs the**
21 **inclusion of the procurement procedures and the standard construction**
22 **clauses (Exhibits A and B) attached hereto.**

1 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it
2 hereby approves the funding request and authorizes the expenditures in
3 the amount of \$1,599,730 to complete tasks indicated in the attached
4 budget for the fiscal year 1999.

5 BE IT FINALLY RESOLVED that funds in the amount of \$1,599,730 are hereby
6 appropriated from the SAWRSA Trust Fund to cover the period from
7 April 1, 1999 through September, 1999.

8 The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH day
9 of JUNE, 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR;
10 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in
11 the Council by Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono
12 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
13 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
14 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
