

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorizing Submission and Negotiation of the Fiscal Year 2000 Annual  
Funding Agreement and Contract Amendment to the Indian Self-Determination  
Act Master Contract with the INDIAN HEALTH SERVICE)**

**RESOLUTION NO. 99-343**

1 WHEREAS, the Tohono O'odham Nation has historically contracted certain functions  
2 from the Indian Health Service pursuant to the authority conferred to the  
3 Nation by the Indian Self-Determination Act, as amended; and

4 WHEREAS, the Tohono O'odham Nation desires to continue operation of such  
5 services and commence operation of certain new functions, services,  
6 activities and programs presently performed by the Indian Health  
7 Service; and

8 WHEREAS, the Nation desires to extend the term of the present Master Contract for  
9 an additional three years until September 30, 2002.

10 NOW, THEREFORE, BE IT RESOLVED that:

- 11 1. The Chairman of the Nation is authorized to submit the attached  
12 Fiscal Year 2000 Annual Funding Agreement to the Indian Health  
13 Service and to negotiate maximum funding and acceptance by the  
14 Indian Health Service of the terms and conditions contained therein.
- 15 2. The Chairman of the Nation is authorized to submit the attached  
16 Amendment No. 1 to the Master Contract extending the term of this  
17 Contract until September 30, 2002.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 11TH day  
19 of JUNE, 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR;  
20 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in  
21 the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham  
22 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by  
23 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
24 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




