

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Submission and Negotiation of the Fiscal Year 2000 Annual
Funding Agreement to the Indian Self-Determination Act Master Contract
with the Bureau of Reclamation)**

RESOLUTION NO. 99-344

1 WHEREAS, the Tohono O'odham Nation has contracted the preparation of a
2 comprehensive water inventory to determine the quantity and quality of
3 the Nation's water resources from the Bureau of Reclamation pursuant to
4 the authority conferred to the Nation by the Indian Self-Determination
5 Act, as amended; and

6 WHEREAS, the Tohono O'odham Nation desires to continue performance of this
7 activity.

8 NOW, THEREFORE, BE IT RESOLVED that:

- 9 1. The Chairman of the Nation is authorized to submit the attached
10 Fiscal Year 2000 Annual Funding Agreement to the Bureau of
11 Reclamation and to negotiate maximum funding and acceptance by
12 the Bureau of Reclamation of the terms and conditions contained
13 therein.

14 The foregoing Resolution was passed by the Tohono O'odham Council on the 11TH day
15 of JUNE, 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR;
16 0 AGAINST; 0 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in
17 the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham
18 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
19 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
20 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
