**RESOLUTION NO. 99-347**

1   **WHEREAS, the Agricultural Extension Program has identified savings of \$40,369.50**  
2                   **from its fiscal year 1999 budget; and**

3   **WHEREAS, identified savings will be used to purchase supplies and equipment the**  
4                   **Agricultural Extension Program needs to sufficiently serve members of**  
5                   **the Tohono O'odham Nation; and**

6   **WHEREAS, the Agricultural Extension Program has identified savings of \$18,963.23**  
7                   **from its fiscal year 1999 budget, attributed from the vacancy of personnel;**  
8                   **and**

9   **WHEREAS, the program's current base budget does not have the necessary line items**  
10                  **to allow for the expenditure of funds to purchase the needed supplies and**  
11                  **equipment; and**

12   **WHEREAS, the Agricultural Extension Program has submitted for review and**  
13                  **approval Budget Modification No. 1 with six (6) new line items added to**  
14                  **the budget.**

15   **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**  
16                  **hereby approves the added six (6) line items for the Agricultural**  
17                  **Extension Program budget: 722 - Program Supplies; 730 - Dues &**  
18                  **Subscriptions; 750 - Capital Equipment; 752 Office and Communication**  
19                  **Equipment; 759 - Other Equipment; and 819.00 Consultants Expenses.**

20   **BE IT FURTHER RESOLVED that the line items be part of the Agricultural Extension**  
21                  **Program's base budget.**

8 the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham  
9 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by  
10 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
11 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


