

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Monetary Donation for Chaz Gilmore to participate in an
International Wrestling Tournament Tour)

RESOLUTION NO. 99-356

1 WHEREAS, Chaz Gilmore was selected to participate in an International Wrestling
2 Tournament Tour; and

3 WHEREAS, the wrestling team is comprised of individuals selected from throughout
4 the United States; and

5 WHEREAS, Chaz is the only Native American and the only Tohono O'odham selected;
6 and

7 WHEREAS, the tournaments will be held in Holland and Germany; and

8 WHEREAS, Chaz is a Chukut Kuk District member residing in the San Xavier District
9 with his mother; and

10 WHEREAS, Chaz is a student at the Sherman Indian School in Riverside, California;
11 and

12 WHEREAS, the Chukut Kuk District and the Tobacco Barn have provided donations
13 for airfare and lodging; and

14 WHEREAS, donation will be utilized to cover the other expenses not included in funds
15 already received.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
17 that it hereby supports and approves the monetary donation request for
18 Chaz Gilmore in the amount of \$793.00 to be appropriated from the 1998
19 savings account.

20 The foregoing Resolution was passed by the Tohono O'odham Council on the 15TH day
21 of JUNE, 1999 at a meeting at which a quorum was present with a vote of 963.0 FOR; 769.2
22 AGAINST; 433.3 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the
23 Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham
24 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
25 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
26 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


