15 **Council by Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the**
16 **Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986;**
17 **and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on**
18 **March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


