(Tohono O'odham Department of Human Services - Division of Child Welfare  
Services - FY99 National Children's Alliance Grant Modification #1)**

**RESOLUTION NO. 99-364**

1   **WHEREAS, the Indian Protection and Family Violence Prevention Act of 1990, 25**  
2                   **USC§§320 et seq., authorizes the use of multi-disciplinary teams to address**  
3                   **the many issues in child abuse and neglect cases; and**

4   **WHEREAS, the National Children's Alliance has awarded the Division of Child Welfare**  
5                   **Services \$35,000 to facilitate the formalization of the Multi-disciplinary**  
6                   **Team; and**


7   **WHEREAS, a budget modification has been submitted which does not change the**  
8                   **Funding level, but includes new line items and modifies other line item**  
9                   **amounts to address current needs.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 11           **1. The Tohono O'odham Legislative Council authorizes expenditures of**  
12                   **these funds according to the attached budget.**
- 13           **2. That the Tohono O'odham Nation, to wit, the Chairman and any**  
14                   **designated Official are hereby authorized to negotiate and execute the**  
15                   **grant.**

16 **The foregoing Resolution was passed by the Tohono O'odham Council on the 13TH day**  
17 **of JULY, 1999 at a meeting at which a quorum was present with a vote of 1,942.9 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and 222.6 [03] ABSENT, pursuant to the powers vested in the**  
19 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
20 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
21 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
22 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
