1	WHEREAS, the Tonono O'odnam Nation has received funding from the State of Arizona
2	Title IIB FY 1998 in the amount of \$175,073.00; and
3	WHEREAS, the State of Arizona has allowed charges in the 1999 fiscal year to be charged
4	against the 1998 budget; and
5	WHEREAS, this Budget Modification #2 replaces a Budget Modification #2 to transfer
6	funds to Title IIC approved through Tohono O'odham Legislative Council
7	during the June 1999 general session; and
8	WHEREAS, approved cost share principals have been established to meet the funding
9	requirements of reasonable, allowable, and allocable.
10	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it
11	hereby approves the State of Arizona Title IIB 1998 Budget Modification #2.
12	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono
13	O'odham Nation's officials, to wit; the Chairman and any designated official
14	are hereby authorized to negotiate and execute the contract, provided
15	however, that any amendment affecting the funding or funding levels of this
16	contract shall be submitted for further prior approval by this Council.
17	The foregoing Resolution was passed by the Tohono O'odham Council on the 13TH, day
18	of <u>IULY</u> , 1999 at a meeting at which a quorum was present with a vote of <u>1.942.9</u> FOR; <u>-0-</u>
19	AGAINST; -0- NOT VOTING; and 222.6 [05] ABSENT, pursuant to the powers vested in the
20	Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,
21	adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
22	Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
23	Section 16 of the Act of June 18, 1934 (48 Stat. 984).
