

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the State of Arizona FY 1999 Contract - Budget IIA,
Budget IIB and IIC)**

RESOLUTION NO. 99-373

1 **WHEREAS, the Tohono O'odham Nation has received funding from the State of Arizona**
2 **for \$339,736.00; and**

3 **WHEREAS, the State of Arizona - Title IIA in the amount of \$148,282.00 with**
4 **Administration, Direct Training and Support Services budget; and**

5 **WHEREAS, the State of Arizona - Title IIB in the amount of \$170,307.00 with**
6 **Administration and Training and Support Services budget; and**

7 **WHEREAS, the State of Arizona - Title IIC in the amount of \$21,147.00 with**
8 **Administration, Direct Training and Support Service Budget; and**

9 **WHEREAS, State of Arizona - Title IIA, IIB, and IIC are to serve clients of the Tohono**
10 **O'odham residing on the Nation and meeting eligibility requirements.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
12 **hereby approves the State of Arizona FY 1999 Contract with Budget Title IIA,**
13 **Title IIB, and IIC in the combined amount of \$339,736.00.**

14 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
15 **O'odham Nation's officials, to wit; the Chairman and any designated official**
16 **are hereby authorized to negotiate and execute the contract, provided**
17 **however, that any amendment affecting the funding or funding levels of this**
18 **contract shall be submitted for further prior approval by this Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Council on the 13TH, day**
21 **of JULY, 1999 at a meeting at which a quorum was present with a vote of 1,942.9 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and 222.6 [05] ABSENT, pursuant to the powers vested in the**
23 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
24 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
25 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
26 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


