5	\$248,847.00; and
6	WHEREAS, the State of Arizona Welfare to Work Budget works with the Department of
7	Labor Welfare to Work budget; and
8	WHEREAS, an increase in funding levels amends the original contract with the State of
9	Arizona.
10	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it
11	hereby approves the State of Arizona Welfare to Work Budget and Contract
12	FY 1998 in the amount of \$248,847.00.
13	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono
14	O'odham Nation's officials, to wit; the Chairman and any designated official
15	are hereby authorized to negotiate and execute the contract, provided
16	however, that any amendment affecting the funding or funding levels of this
17	contract shall be submitted for further prior approval by this Council.
18	The foregoing Resolution was passed by the Tohono O'odham Council on the 13TH, day
19	of <u>JULY</u> , 1999 at a meeting at which a quorum was present with a vote of <u>1,942.9 FOR</u> ; <u>-0-</u>
20	AGAINST; <u>-0-</u> NOT VOTING; and <u>222.6 [06]</u> ABSENT, pursuant to the powers vested in the
21	Council by Section <u>1 (f)</u> of Article VI of the Constitution of the Tohono O'Odham Nation,
22	adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
23	Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
24	Section 16 of the Act of June 18, 1934 (48 Stat. 984).
