

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Brooks Taylor to the Tohono O'odham Farming Authority
Management Board)**

**DEFEATED
RESOLUTION NO. 99-378**

1 **WHEREAS, the Second Restated Plan of Operation for the Tohono O'odham Farming**
2 **Authority calls for the appointment of the Directors of the Farming Authority**
3 **Management Board by the Chairman of the Tohono O'odham Nation, with the**
4 **approval of the Legislative Council; and**

5 **WHEREAS, Brooks Taylor has been nominated to serve as a Professional Representative**
6 **Director in accordance with Section with Section 4.1.3 of the Second Restated**
7 **Plan of Operation for the Tohono O'odham Farming Authority; and**

8 **WHEREAS, the Chairman of the Nation has appointed Mr. Taylor to serve as a Professional**
9 **Representative Director for an initial term of one year in accordance with**
10 **Sections 4.1.3 and 4.3.1 of the Second Restated Plan of Operation for the**
11 **Tohono O'odham Farming Authority; and**

12 **WHEREAS, Mr. Taylor agrees to serve as a Director for that term.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
14 **the appointment of Brooks Taylor to serve as a Professional Representative**
15 **Director on the Management Board of the Tohono O'odham Farming**
16 **Authority for an initial term of one year which term shall end on August 31,**
17 **2000.**

18 **The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the**
19 **14TH. Day of JULY, 1999 at a meeting at which a quorum was present, and by a vote of 790.85**
20 **FOR; 929.9 AGAINST; 222.15 NOT VOTING; and 222.6 [04] ABSENT, failed to pass because it did**
21 **not receive a majority of the votes cast as required by Section 2 of Article V of the**
22 **Constitution of the Tohono O'odham Nation.**
