

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Scott Hathorn, Jr. to the Tohono O'odham Farming Authority
Management Board)**

**DEFEATED
RESOLUTION NO. 99-379**

1 **WHEREAS, the Second Restated Plan of Operation for the Tohono O'odham Farming**
2 **Authority calls for the appointment of the Directors of the Farming Authority**
3 **Management Board by the Chairman of the Tohono O'odham Nation, with the**
4 **approval of the Legislative Council; and**

5 **WHEREAS, Scott Hathorn, Jr. has been nominated to serve as a Professional**
6 **Representative Director in accordance with Section with Section 4.1.3 of the**
7 **Second Restated Plan of Operation for the Tohono O'odham Farming**
8 **Authority; and**

9 **WHEREAS, the Chairman of the Nation has appointed Mr. Hathorn to serve as a**
10 **Professional Representative Director for an initial term of one year in**
11 **accordance with Sections 4.1.3 and 4.3.1 of the Second Restated Plan of**
12 **Operation for the Tohono O'odham Farming Authority; and**

13 **WHEREAS, Mr. Hathorn agrees to serve as a Director for that term.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
15 **the appointment of Scott Hathorn, Jr. to serve as a Professional Representative**
16 **Director on the Management Board of the Tohono O'odham Farming**
17 **Authority for an initial term of one year which term shall end on August 31,**
18 **2000.**

19 **The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the**
20 **14TH. Day of JULY, 1999 at a meeting at which a quorum was present, and by a vote of 790.85**
21 **FOR; 929.9 AGAINST; 222.15 NOT VOTING; and 222.6 [04] ABSENT, failed to pass because it did**
22 **not receive a majority of the votes cast as required by Section 2 of Article V of the**
23 **Constitution of the Tohono O'odham Nation.**
