1 **WHEREAS, the Advocate Program is seeking to reclassify two positions to wit:**
2 **Administrative Secretary (132.06) to Administrative Assistant (140.01) and;**
3 **Attorney II (166.01) to Assistant Chief Advocate (168.01); and**

4 **WHEREAS, reclassification is appropriate to more accurately reflect increased duties and**
5 **responsibilities; and**

6 **WHEREAS, the additional cost to the Nation of these proposed reclassifications for FY '99**
7 **is as follows:**

Administrative Assistant

Salary - \$587.81 (6/1/99 - 9/30/99)

Fringe Benefits - \$188.03

TOTAL \$775.84

Assistant Chief Deputy

Salary - \$618.51 (5/28/99 - 9/30/99)

Fringe Benefits - \$204.11

TOTAL \$822.62

15 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
16 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
