

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending the TOUA Subsidy Implementation Plan)**

RESOLUTION NO. 99-385

1 **WHEREAS, on June 28, 1997, the voters of the Tohono O'odham Nation approved Initiative**  
2 **No. IN-01-97 (the "Initiative") which sets aside \$1 million to establish a welfare**  
3 **fund to provide qualified elderly and low-income members of the Nation with**  
4 **assistance payments covering the cost of utility services provided by the**  
5 **Tohono O'odham Utility Authority; and**

6 **WHEREAS, in order to implement the Initiative, the Tohono O'odham Legislative Council**  
7 **did adopt the Initiative Funding and Implementation Plan of October 14, 1997**  
8 **by Resolution No. 97-451; and**

9 **WHEREAS, the Tohono O'odham Legislative Council did approve the TOUA Subsidy**  
10 **Implementation Plan of November 3, 1998 by Resolution No. 98-473; and**

11 **WHEREAS, TOUA has added propane to its energy offerings and desires that propane be**  
12 **included in the eligible services for Utility Cost Assistance.**

13 **NOW, THEREFORE, BE IT RESOLVED THAT:**

14 **The Legislative Council hereby approves the first amendment to the TOUA**  
15 **Subsidy Plan to include propane as an eligible service to receive the Utility**  
16 **Cost Assistance.**

17 **The foregoing Resolution was passed by the Tohono O'odham Council on the 14TH day of**  
18 **JULY, 1999 at a meeting at which a quorum was present with a vote of 1,654.8 FOR; -0-**  
19 **AGAINST; 128.1 NOT VOTING; and 382.6 [06] ABSENT, pursuant to the powers vested in the**  
20 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
21 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
22 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
23 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**






