

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 99-390, "Permitting, Safe Ride Services, Inc. to  
Continue to Provide Non-Emergency Medically Necessary Transportation  
Services on the Tohono O'odham Nation")**

**RESOLUTION NO. 99-391**

1 **WHEREAS, on July 15, 1999, the Legislative Council did enact Resolution No. 99-390,**  
2 **"Permitting, Safe Ride Services, Inc. to Continue to Provide Non-Emergency**  
3 **Medically Necessary Transportation Services on the Tohono O'odham**  
4 **Nation;"and**

5 **WHEREAS, Resolution No. 99-390 authorized and granted Safe Ride Services, Inc.**  
6 **permission to provide non-emergency Medically necessary transportation**  
7 **services within the Nation for six (6) months from the date of enactment of**  
8 **the resolution; and**

9 **WHEREAS, a motion was made to amend the authorization period in its resolving**  
10 **clause.**

11 **NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council that it**  
12 **hereby amends Resolution No. 99-390 resolving clause No. 1 to read:**

- 13 **1. Safe Ride Services, Inc. is authorized and granted permission to provide**  
14 **medically necessary transportation services within the Nation for three**  
15 **(3) months from the date of enactment of the resolution.**

16 **The foregoing Resolution was passed by the Tohono O'odham Council on the 15TH. day**  
17 **of JULY, 1999 at a meeting at which a quorum was present with a vote of 1,186.9 FOR;**  
18 **756.0 AGAINST; -0- NOT VOTING; and 222.6 [04] ABSENT, pursuant to the powers vested in**  
19 **the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham**  
20 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by**  
21 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
22 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


