7	mainly Travel & Transportation and the Committee does feel that this
8	supplemental funding is a necessity to continue pursuing the Goals &
9	Objectives of the Miss Tohono O'odham Committee.
10	NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves the 1999 Fiscal
11	Year Supplemental Budget for the Miss Tohono O'odham Nation Committee in
12	the amount of \$28,011.47.
13	BE IT FURTHER RESOLVED that funds for the supplemental funding will be appropriated
14	from the FY 1998 savings.
