

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sif Oidak District FY 2000 Budget in the amount of \$980,730.00)**

RESOLUTION NO. 99-404

1 **WHEREAS, the Sif Oidak District Council approved their FY 2000 budget at a meeting held**
2 **on June 26, 1999; and**

3 **WHEREAS, on July 16, 1999, the Sif Oidak District presented their FY 2000 budget request**
4 **in the amount of \$980,730.00 to the Tohono O'odham Legislative Council for**
5 **their approval; and**

6 **WHEREAS, the Sif Oidak District does have sufficient funds in their own account to**
7 **implement the budget amount requested.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does**
9 **hereby support and approve the FY 2000 Sif Oidak District budget in the**
10 **amount of \$980,730.00.**

11 **BE IT FURTHER RESOLVED that Salaries (\$241,500.00) and Fringe Benefits (\$77,280.00)**
12 **be transferred to the Tohono O'odham Nation Accounting Department for**
13 **payment to District employees.**

14 **BE IT FINALLY RESOLVED that the Sif Oidak District be authorized to expend their FY 2000**
15 **budget from August 01, 1999 to July 31, 2000.**

17 **The foregoing Resolution was passed by the Tohono O'odham Council on the 16TH day of**
18 **JULY, 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council**
20 **by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation,**
21 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
22 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
23 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
