7	WHEREAS,	the Baboquivari District communities budgeted for the needs of their						
8		respective communities and community members; and						
9	WHEREAS,	the Baboquivari District maintains that the amount of \$4,290.00 would						
10		jeopardize the needs of the communities of Baboquivari District and its						
11		members.						
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby							
13		appropriates the amount of \$4,290.00 (Four thousand two hundred ninety						
14		dollars and no cents) for a "Special Election" in behalf of Baboquivari District.
