

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2000 Projected Revenues in the Amount of \$33,333,000)**

**RESOLUTION NO. 99-413**

1 **WHEREAS, the Budget and Finance Committee reviewed the actual revenues for FY 1999;**  
2 **and**

3 **WHEREAS, revenue sources for FY 2000 have been adjusted to reflect changes from actual**  
4 **revenues for FY 1999; and**

5 **WHEREAS, the Budget and Finance Committee recommends adoption of the FY 2000**  
6 **projected revenues in the amount of \$33,333,000 to fund the Nation's budget**  
7 **for FY 2000.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**  
9 **hereby approves the attached projected revenues, in the amount of**  
10 **\$33,333,000 for the purpose of funding the FY 2000 budgets of the Tohono**  
11 **O'odham Nation.**

12 **The foregoing Resolution was passed by the Tohono O'odham Council on the 26TH. day of**  
13 **JULY, 1999 at a meeting at which a quorum was present with a vote of 1,824.85 FOR; 235.85**  
14 **AGAINST; 104.8 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**  
15 **by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
16 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
17 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
18 **of the Act of June 18, 1934 (48 Stat. 984).**


