

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving District Allocations by Population)**

**RESOLUTION NO. 99-414**

1   **WHEREAS, during the Special Session on July 26, 1999, the Legislative Council did address**  
2                   **the FY 2000 Revenue Projections and approved an amount of \$33,333,000; and**  
3   **WHEREAS, a motion was made to distribute district allocations based on population.**  
4   **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
5                   **authorizes District allocations by population to the eleven (11) districts of the**  
6                   **Tohono O'odham Nation.**  
7   **BE IT FURTHER RESOLVED that such distributions shall be expended by the District**  
8                   **Councils under budgets or resolutions duly approved by the Tohono O'odham**  
9                   **Legislative Council for Fiscal Year 2000.**

11   **The foregoing Resolution was passed by the Tohono O'odham Council on the 26TH day of**  
12   **JULY, 1999 at a meeting at which a quorum was present with a vote of 1,091.4 FOR; 1,074.1**  
13   **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**  
14   **by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
15   **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
16   **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
17   **of the Act of June 18, 1934 (48 Stat. 984).**


