1 BE IT FURTHER RESOLVED that the Chairman and other appropriate
2 officers of the Tohono O'odham Nation reduce this final determination in
3 writing regarding each of the foregoing applications for enrollment in
4 accordance with Section 1(a) of Article XIII of the Enrollment Ordinance; give
5 notice of this Council's determination in accordance with Section 2 of Article
6 XIII of the Enrollment Ordinance; and place the names of each applicant upon
7 the membership roll of the Tohono O'odham Nation in accordance with
8 Sections 2 and 3 of Article X of the Enrollment Ordinance.

9 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the
10 02ND Day of AUGUST, 1999 at a meeting at which a quorum was present with a vote of 2,165.5
11 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the
12 Council by Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the
13 Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
14 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March
15 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
