

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Enrollment - August (2))**

**RESOLUTION NO. 99-426**

1 **WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the**  
2 **Enrollment Committee in accordance with Section I of Article VIII of the**  
3 **Enrollment Ordinance, Ordinance No. 05-81, and has made a final**  
4 **determination that the application of the following applicant for membership**  
5 **in the Tohono O'odham Nation be approved:**

**ARTICLE II - MEMBERSHIP  
SECTION (1)(b) ALL CHILDREN BORN TO RESIDENT MEMBERS**

3002-ND-98            **VELASCO-LEON, Brenda F.**

4067-ND-99            **CRUZ-VELASCO, Edwin R.**

11 **NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above named**  
12 **applicant is eligible for enrollment as a member of the Tohono O'odham**  
13 **Nation under Section 1(a) or (b) of Article II of the Constitution of the Tohono**  
14 **O'odham Nation, and that their application is approved, as herein above**  
15 **indicated.**

16 **BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the**  
17 **Tohono O'odham Nation reduce this final determination in writing regarding**  
18 **each of the foregoing applications for enrollment in accordance with Section**  
19 **1(a) of Article XIII of the Enrollment Ordinance; give notice of this Council's**  
20 **determination in accordance with Section 2 of Article XIII of the Enrollment**  
21 **Ordinance; and place the names of each applicant upon the membership roll**  
22 **of the Tohono O'odham Nation in accordance with Sections 2 and 3 of Article**  
23 **X of the Enrollment Ordinance.**

24 **The foregoing Resolution was passed by the Tohono O'odham Council on the 03<sup>RD</sup> Day of**  
25 **AUGUST, 1999 at a meeting at which a quorum was present with a vote of 2,086.45 FOR; -0-**  
26 **AGAINST; 79.05 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council**  
27 **by Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono**  
28 **O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and**  
29 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March**  
30 **6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


