


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Appointment of Richard D. Clifton as Chairperson of the Tribal  
Emergency Response Commission)**

**RESOLUTION NO. 99-429**

1 **WHEREAS, the Tohono O'odham Legislative Council adopted the Emergency Planning**  
2 **and Community Right-To-Know Ordinance (Ord. No. 98-02) through**  
3 **Resolution No. 98-210 on June 01, 1998; and**  
4 **WHEREAS, Section 4(b) of this Ordinance states that the appointment of a Chairperson of**  
5 **the Tribal Emergency Response Commission (TERC) must be approved by this**  
6 **Council; and**  
7 **WHEREAS, Chairman Edward D. Manuel has nominated Richard D. Clifton, Director of**  
8 **Department of Public Safety as the TERC Chairperson; and**  
9 **WHEREAS, the Legislative Council agrees with Chairman Manuel that Mr. Clifton has the**  
10 **right combination of experience and knowledge for this position.**  
11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
12 **approves the appointment of Richard D. Clifton as Chairperson of the Tribal**  
13 **Emergency Response Commission.**

14 **The foregoing Resolution was passed by the Tohono O'odham Council on the 03<sup>RD</sup> day of**  
15 **AUGUST 1999 at a meeting at which a quorum was present with a vote of 1,580.35 FOR; 585.15**  
16 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council**  
17 **by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
18 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
19 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
20 **of the Act of June 18, 1934 (48 Stat. 984).**


