

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Appointment of Priscilla Domingo to the Tohono O'odham Nursing
Care Authority Board of Directors)**

RESOLUTION NO. 99-435

1 **WHEREAS, by Resolution No. 98-512, the Legislative Council did adopt and approve the**
2 **Tohono O'odham Nursing Care Authority Charter for the Tohono O'odham**
3 **Nation Skilled Nursing Facility; and**

4 **WHEREAS, the Tohono O'odham Nursing Care Authority is established by the Tohono**
5 **O'odham Nation pursuant to Article VI, Section 1 (e) of the Nation's**
6 **Constitution as an exercise of the Nation's sovereign right of self-government;**
7 **and**

8 **WHEREAS, a Board consisting of seven Directors shall be nominated by the Chairman of**
9 **the Nation and confirmed by the Legislative Council; and**

10 **WHEREAS, the Chairman of the Nation did select a list of seven names nominated to sit as**
11 **Directors of the Tohono O'odham Nursing Care Authority; and**

12 **WHEREAS, Priscilla Domingo is nominated and has sufficient experience, education and**
13 **dedication to the improvement of elderly health care for the O'odham to make**
14 **sound judgements concerning the operation of the skilled nursing facility;**
15 **and**

16 **WHEREAS, as a member of the Tohono O'odham Nursing Care Authority, the individual**
17 **shall conduct the business affairs of the Authority.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council, upon**
19 **nomination by the Chairman of the Nation, hereby approves the appointment**
20 **of Priscilla Domingo to serve a four (4) year term as a Tohono O'odham**
21 **Nursing Care Authority Board member.**

22 **The foregoing Resolution was passed by the Tohono O'odham Council on the 03RD. day of**
23 **AUGUST 1999 at a meeting at which a quorum was present with a vote of 1.722.35 FOR; 315.05**
24 **AGAINST; -0- NOT VOTING; and 128.1 [07] ABSENT, pursuant to the powers vested in the**
25 **Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation,**
26 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
27 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
28 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
