(Approval of Re-application of Department of Human Services/Division of
Child Welfare Services - FY 2000 Title IV-B Child Welfare Service Subpart 1
and Promoting Safe and Stable Families, Subpart 2, Social Security Act)**

RESOLUTION NO. 99-437

1 **WHEREAS, the Tohono O'odham Nation has always had a desire to provide for the health**
2 **and welfare needs of O'odham children and families; and**

3 **WHEREAS, the Tohono O'odham Department of Human Services/Child Welfare Services**
4 **has the primary responsibility to provide for those families found to be in**
5 **need of such care; and**

6 **WHEREAS, the Title IV-B, Subpart 1 and Subpart 2 of the Social Security Act provides**
7 **funds for development of a five year plan for demonstrating effective**
8 **prevention approaches for handling increasing family problems under**
9 **specified terms and conditions; and**

10 **WHEREAS, in FY 2000 a five year plan is submitted by the Human Services/Child Welfare**
11 **Division; and**

12 **WHEREAS, Title IV-B, Subpart 1 and Subpart 2 requires yearly re-application for funds to**
13 **support the five year plan.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 15 **1. It does hereby approve the re-application of the Tohono O'odham**
16 **Department of Human Services to continue the implementation of the FY**
17 **2000 Five Year Plan.**
- 18 **2. It does approve the Title IV-B application funding in the amount of**
19 **\$45,931.00 for Subpart I, and \$39,685.00 for Subpart II.**
- 20 **3. That the budget period is FY 99 (October 1, 1999 - September 30, 2000).**
- 21 **4. The Tohono O'odham Nation Officials, to wit, the Chairman and Vice**
22 **Chairman and any designated Official are hereby authorized to negotiate**
23 **and execute the grant.**
