

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2000 Food Distribution Program - Budget Proposal)**

RESOLUTION NO. 99-441

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Food Distribution**
2 **Program under an FY 1999 Grant with the United States Department of**
3 **Agriculture; and**

4 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono**
5 **O'odham Nation and its people; and**

6 **WHEREAS, the Tohono O'odham Nation does desire to renew for provision of services;**
7 **and**

8 **WHEREAS, the Tohono O'odham Nation Legislative Council has reviewed and approves**
9 **the FY 2000 Food Distribution Program proposal and budget.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
11 **does authorize and request the United States Department of Agriculture to**
12 **renew with the Tohono O'odham Nation for provision of services titled: Food**
13 **Distribution Program.**

14 **BE IT FURTHER RESOLVED that the duration of this grant shall be from October 01, 1999**
15 **and as long as there is funding for the Food Distribution Program.**

16 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
17 **O'odham Nation will not fund or operate the program in the interim while**
18 **negotiations are still be conducted and no executed grant has been approved**
19 **by the United States Department of Agriculture.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
21 **O'odham Nation Officials, to wit: the Chairman, Vice Chairman and any**
22 **designated official are hereby authorized to negotiate and execute the grant,**
23 **provided however, that any amendments affecting the funding or funding**
24 **level of the grant shall be submitted for further prior approval by this Council.**

1 The foregoing Resolution was passed by the Tohono O'odham Council on the 04TH day of
2 AUGUST, 1999 at a meeting at which a quorum was present with a vote of 1,993.7 FOR; -0-
3 AGAINST; -0- NOT VOTING; and 171.8 [04] ABSENT, pursuant to the powers vested in the
4 Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,
5 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
6 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
7 Section 16 of the Act of June 18, 1934 (48 Stat. 984).


